Noncash award usage is monitored internally when Mercy's Gate disburses award funds directly to agencies on behalf of the individuals. Cash assistance requires an application to be completed each time cash assistance is requested. Cash assistance is generally given in small amounts and no further monitoring is practical.

Utilities assistance is provided through Energy Outreach Colorado and Project COPE administered through the Colorado Springs Utilities Foundation. These programs provide utilities payment assistance to families and individuals struggling financially due to a personal crisis or emergency. Mercy's Gate serves as a partner agency working directly with customer applicants seeking assistance through the programs. Utilities assistance granted is transferred within the Colorado Springs Utilities system. Through this essential service, Mercy's Gate obtained relief for 523 households (1,520 individuals) valued at \$307,762 during calendar year
