MORE THAN 970 HOT MEALS WERE SERVED DURING OPEN HOURS WHEN PEOPLE VISITED MERCY'S GATE SEEKING EMERGENCY ASSISTANCE. RENTAL OR MORTGAGE ASSISTANCE OF \$84,285 WAS PROVIDED TO 276 FAMILIES, HELPING 826 PEOPLE AVOID EVICTION AND HOMELESSNESS. THE COLORADO SPRINGS UTILITIES' PROJECT COPE PROVIDED ASSISTANCE TO 106 FAMILIES FACING DISCONNECTION OF THEIR UTILITIES. ENERGY OUTREACH COLORADO PROVIDED ASSISTANCE TO AN ADDITIONAL 100 HOUSEHOLDS.
